with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: PAYRLE: \$15.00 on the 9th day of October, 1955, and a like payment of \$15.00 on the 9th day of each month thereafter, said payments to be applied first to interest balance to principal, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in the City of Greenville, being known and designated as lot # H, on plat of property of North Hills, recorded in Plat Book H at Page 90, being more particularly described according to survey and plat prepared by Pickell & Pickell, on October 11, 1945, as follows:

"BEGINNING at a stake on the North side of Garraux Street, at front corner of lots # G and H, which st ke is 40 feet East of the Northeast corner of Elizabeth Street, and Garraux Street; thence with line of lot G, N. 22-05 E. 147.8 feet to stake on a 10 foot alley; thence with said alley, S. 66-02 E. 50 feet to a stake; thence with the line of lot I, S. 22-05 W. 147.8 feet to a stake on Garraux Street; thence with said Street, N. 66-02 W. 50 feet to the point of beginning."
