SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eleven Thousand. Three Hundred and No/100 - - - - -

(\$\frac{11.300.00}{\text{o}}\) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of

One Hundred. Thirteen and No/100 - - - - - - - (\$ 113.00)

LOT NO. 11: BEGINNING at an iron pin on the east side of the Old Augusta Road at the joint front corner of Lots Nos. 10 and 11, and running thence along the east side of the Old Augusta Road, S. 4-28 E. 85 feet to an iron pin at the joint front corner of Lots Nos. 11 and 12; thence along the joint line of said lots, S. 87-44 E. 102 feet to an iron pin at the joint rear corner of said lots; thence N. 8-58 E. 85 feet to an iron pin at the joint rear corner of Lots 10 and 11; thence along the joint line of said lots, N. 87-47 W. 121.9 feet to the beginning corner.

LOT NO. 12: BEGINNING at an iron pin on the east side of the Old Augusta Road at the joint front corner of Lots Nos. 11 and 12, and running thence along the east side of the Old Augusta Road, S. 13-46 E. 88.3 feet to an iron pin; thence continuing along the east side of the Old Augusta Road, S. 20-00 E. 134.3 feet to an iron pin; thence N. 8-58 E. 219.5 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence along the joint line of said lots, N. 87-44 W. 102 feet to the beginning corner.
