DOLLARS (\$ 2000.00

with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid: PAYABLE: \$15.00 on the 30th day of October and a like payment of \$15.00 on the 30th day of each month thereafter until paid in full with interest thereon from date at the rate of five (5%) per cent. per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot 106 as shown on plat of Piedmont Estates recorded in Plat Book "M" at Page 123, and being more particularly described according to a recent survey prepared by C. C. Jones, Engineer, as follows:

"BEGINNING at an iron pin in the northeastern side of Churchill Avenue which pin is 120 feet west of the intersection of Churchill Avenue and Omar Avenue and running thence with Churchill Avenue N. 66-00 W. 60 feet to an iron pin corner of Lot 107; running thence with the line of said lot N. 24-00 E. 175 feet to an iron pin; thence S. 66-00 E. 60 feet to an iron pin rear corner of Lot 105; thence with the line of said lot S. 24-00 W. 175 feet to the point of beginning."

Being the same premises conveyed to the mortgagors by deed of Henry Harding to be recorded.

It is understood and agreed that this mortgage is junior in lien to a mortgage held by Independent Life & Accident Insurance Company in the original sum of \$5200.00 recorded in Mortgage Book 652 at Page 509.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
