"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, located near Double Springs Baptist Church and on the South side of the McElhaney Road, bounded on the North by lands of W.A. Clark, on the East and South by lands of Julius T.
