"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs, Township, in or near the City of Greer, located on the North side of Pennsylvanie Avenue, being all of Lot No. 8 in Block H on a plat of made by H.S. Brockman, Surveyor, dated April 21, 1919, and having the following courses and distances: BEGINNING on a stake on the North side of Pennsylvania Avenue, and runs thence N. 16.31 E. 236.7 feet to a stake on the right-of-way of the P. & N.
