Lanneau Drive, being shown as Units 6 and 7 on plat of Addition No. 1 to Forest Hills recorded in Plat Book "D" at Fages 226-227, and having according to said plat, when described as a whole, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of E.
