with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: in monthly installments of \$50.00 each on the 29th day of each month hereafter until paid in full, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed andpaid semi-annually in advance

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Northwestern side of Toler Road, being shown as lot #19 on plat of Meadowbrook Farms, recorded in the R.M.C. Office for Greenville County in Plat Book M at Page 22, and described as follows:

*BEGINNING at a stake on the Northwestern side of Toler Road, 126.2 feet Southwest from Sullivan Road, at corner of lot # 20, and running thence with the line of said lot, N. 32-15 W. 277.5 feet to a stake; thence S. 57-45 W. 62 feet to a stake at corner of lot #18; thence with line of said lot, S. 32-15 E. 277.5 feet to a wtake on Toler Road; thence with the Northwestern side of said road, N. 57-45 E. 62 feet to the beginning corner."
