Clyde Corn and Frances W. Corn of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co.

organized and existing under the laws of the State of South Carolina, a corporation called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand Six Hundred Fifty Dollars (\$9,650.00), with interest from date at the rate of four and one-half per centum (4-1/2%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Fifty Three and 65/100 Dollars (\$ 53.65), commencing on the first day of January, 1956, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 1980.

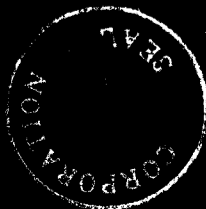
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: near the City of Greenville, S. C. being known as lot no. 6 on plat of property of W. M. Edwards made by Piedmont Engineering Service recorded in the R.M.C. Office for Greenville County in Plat Book BB at Page 80 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Elaine Drive, at the joint front corner of lots nos. 5 and 6, which iron pin is situate 610.9 feet southeast of the intersection of Elaine Drive and Lee Road and running thence along the southwestern side of Elaine Drive, S 33-19 E, 88 feet to an iron pin, corner of lot no. 7; thence with the line of lot no. 7, S 56-41 W, 175 feet to an iron pin, rear corner of lot no. 7; thence N 33-19 W, 33.6 feet to an iron pin; thence N 16-12 W, 57.1 feet to an iron pin, rear corner of lot no. 5; thence with the line of lot no. 5, N 56-41 E, 154.5 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
