All that certain parcel or tract of land containing Thirty (30) Acres, more or less, situated on the Greer-Landrum Road (State Highway No. 14) about ten miles northward from Greer, in Highland Township, Greenville County, State of South Carolina, having the following courses and distances, to wit:

Beginning on the south side of said highway, corner of Black's land, and running thence S. 55 1/4 E. 35.33 chains to a pine knot; thence N. 31.00 E. 8.96 chains to a stone, Kemp's corner; thence N. 53 1/4 W. 33.75 chains to an iron pin in highway; thence along said highway, S. 50-3/4 W. 3.62 chains and S. 36 1/4 W. 5.23 chains to the beginning corner.
