WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN
ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's
promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 13,000.00), with interest thereon from date at the rate of Six (6%)
per centum per annum, said principal and interest to be repaid as therein stated, and

fore the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bar-
gained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its
successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon,
situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Dell-
wood Drive in the City of Greenville, being shown as Lot No. 137 on plat
of property of Central Development Corporation, recorded in the R.M.C. Of-
fice for Greenville County, S. C. in Plat Book "BB", at pages 22 and 23;
said lot fronting 80 feet along the East side of Dellwood Drive; running
back to a depth of 180.5 feet on the North side, to a depth of 175 feet on
the South side and being 79.7 feet across the rear.
