"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of A Street near the City of Greenville, being shown as Lot No. 129 on Plat of Section I of F. W. Poe Manufacturing Company, made by Dalton & Neves in July, 1950, recorded in Plat Book "Y" at Pages 26-31 and described as follows:

"BEGINNING at a stake on the southern side of A Street 73.9 feet west from Fifth Avenue at corner of Lot 169 and running thence with the line of said lot S. 41-12 E. 86.8 feet to a stake in line of Lot 168; thence with the line of Lots 168 and 130 S. 49-04 W. 57.6 feet to a stake at corner of Lot 128; thence with the line of said lot N. 41-15 W. 86.6 feet to a stake on A Street; thence with the southern side of A Street N. 48-50 E. 57.7 feet to the beginning corner."
