MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Everett M. Martin, of Greenville County,

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Five Thousand, Four Hundred and No/100 - -

(\$ 5,400.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of Forty-Five and 57/100 - - - - - - - - - - upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt gain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the north side of Martin Street (now known as Tampa Street), near the City of Greenville in that section known as Sans Souci, being shown as Lot No. 44 on plat of Elizabeth Heights made by C. M. Furman, Jr., Engineer, April, 1925, recorded in the R. M. C. office for Greenville County in Plat Book F, at page 298, and having, according to a more recent survey made by A. C. Crouch, Engineer, May 29, 1950, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Martin Street at the joint front corner of Lots 43 and 44, said pin being 50 feet east from the northeast corner of the intersection of Martin Street and Herbert Street, and running thence along the line of Lot 43, N. 13-45 E. 131.9 feet to an iron pin; thence S. 84-54 E. 50.6 feet to an iron pin; thence with the line of Lot 45, S. 13-45 W. 139.5 feet to an iron pin on the north side of Martin Street; thence with the north side of Martin Street, N. 76-15 W. 50 feet to the beginning corner; being the same conveyed to me by B. L. Mackey by deed of even date herewith, not yet recorded."

The last payment on this mortgage, if not sooner paid, will become due and payable 15 years after date.
