sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot No. 30, Plat of Belle
Meade, Property of Derby Heights, Inc., plat of which is recorded in the R.M.C.
Office for Greenville County, South Carolina, in Plat Book "EE", pages 116-117; said
