NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, in the Town of Taylors on the south side National Highway and known and designated as Lot No. 11 as shown on a plat of the property of Claud E. Shockley, recorded in Plat Book "F" at Page 89, and being more particularly described according to said plat as follows:

"BEGINNING at a stake on the south side of said National Highway joint front corner of Lots No. 11 and No. 12, and running thence along said highway in an easterly direction 50 feet to a stake, joint corner of Lots No. 10 and No. 11; thence at right angles in a southerly direction 231 feet to the joint corner of said lots No. 10 and No. 11, at the edge of the right of way of the P & N Railway; thence along said right of way 56 feet to a stake at joint corner of Lots No. 11 and No. 12; thence with joint line of said lots in a northerly direction 257 feet to the beginning corner."
