(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

TWO HUNDRED TWENTY-FIVE
DOLLARS (\$ 225.00), with interest thereon from date at the rate of Six

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, located on the northeast side of Carolina Avenue, being known as Lot No. 12 of Development No. 2 of Victor-Monaghan Company, Division of J.P. Stevens & CO. Inc., Greer Plant, according to a plat and survey by Dalton & Neves, Engineers, dated April, 1947, recorded in Plat Book "P", at page 119, in the R.M.C. Office for Greenville County.

This is the same property conveyed to the mortgagors by J.P. Stevens & Co., by deed recorded in the R.M.C. Office for Greenville County in Deed Book 351, at page 337.

This mortgage is in addition to that mortgages now held by the mortgagee herein on the above lot.
