All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the easterly side of Welcome Street, near the
City of Greenville, South Carolina, being shown as Lot No. 24 on the plat of
Talmer Cordell Subdivision as recorded in the RMC Office for Greenville County,
S. C. in Plat Book "X", page 179, said lot fronting 60 feet on the easterly side
of Welcome Street and having a depth of 160 feet on the northerly side, a depth of
160 feet on the southerly side, and being 60 feet across the rear.
