

PRACT NO. XX--R.

Containing 51 acros purchased from C. C. Hargrave (see deed from C. C. Hargrave to W. C. Norman) and more particularly described as follows:

BEGINNING at a stake on public road; corner to widows dower, thence South 62 degrees West 10.16 chains to a stake; thence South 53 degrees West 5.42 chains to a stake corner to Lot No. 5; thence North 19½ degrees West 35.62 chains to a stake on G. F. Hedrick's land; thence South 88½ degrees East 19.56 chains to a stake near an old road Hedrick's line; thence South 1½ degrees West 6.55 chains to a stone Hedrick's corner and corner to widows dower; thence South 18½ degrees East 19.50 chains to the beginning, containing Fifty-One (51) acres, more or less. DEGINNING of a large stone, Nath Bailey's and Coble's corner and running the set with Bailey's line North 67 degrees West 220 feet to an iron stake, new corner to Bailey; thence with a new line to Bailey South 7 degrees 10 minutes West 710 feet to a point on Coble's line; thence with Coble's line North 25 degrees 30 minutes East 680 feet to the point of beginning, containing 1.70 acres, more or less, and being of a triangular shape.
