NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All those two pieces parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the scuthern side of Marion Road in Greenville Township, being shown as Lots 86 and 86-C on plat of property of Roscoe W. Manley made by T. C. Adams August 1955, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Marion Road at the joint front corner of Lots 86 and 86-A and running thence with the line of Lot 86-A S. 16-30 E. 114.7 feet to an iron pin; thence S. 53-40 W. 92.2 feet to an iron pin; thence N. 49-20 W. 181.4 feet to an iron pin; thence N. 15-30 E. 77 feet to an iron pin on Marion Road; thence with the southern side of Marion Road S. 72-50 E. 80.3 feet to an iron pin; thence continuing with said road S. 72-50 E. 14.3 feet to pin; thence still continuing with said road N. 89-03 E. 65.8 feet to the point of beginning."

Said premises being the same property conveyed to the mortgagor by two separate deeds recorded in Deed Book 534 at Page 74 and Deed Book 528 at Page 341.
