TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Helen K. McRae and Maude G. Keating, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Five Hundred ----- DOLLARS (\$ 500.00 ), with interest thereon from date at the rate of seven (7%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the west side of North Main Street and the south side of Arlington Avenue in the City of Greer, having the following courses and distances, to wit:

Beginning at an iron pin on the west side of North Main Street, corner of Turner's property, and running thence along the Turner line, N. 58.36 W. 212.7 feet to an iron pin, including alley; thence N. 34.22 E. 30 feet to an iron pin on the south side of W. Arlington Avenue; thence along said Avenue, 214 feet to North Main Street; thence along North Main Street 100 feet to the beginning corner.
