All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, in the Pleasant Grove Church community, lying north from the Old Green-ville-Spartanburg about 300 feet, being bounded on the northern and southern sides by other lands of myself, on the eastern side by lands of the W. A. Mullinax Subdivision and on the western side by lands of Mrs. R. L. Childress, and being a part of the same land that was conveyed to me by deed recorded in the R. M. C. office for Greenville County, South Carolina, in Deed Book 296 at page 108, and having the following courses and distances, to wit:-

Beginning on a stake in the driveway to 2. B. Smith's home and on the former W. A. Mullinax line, said stake being 221 feet from northeas rear corner of J. B. Smith, and runs thence S. 44-15 W. 206.4 feet to a stake on the Mrs. R. L. Chikdress line; thence with the said line, S. 39-15 E. 105 feet to a stake on the said line; thence N. 44-15 E. 214.2 feet to a stake in the said driveway and on the former Mullinax line; thence with the said line and driveway, N. 43-30 W. 105 feet to the beginning corner, containing One Half (0.50) acre, more or less.
