TO ALL WHOM THESE PRESENTS MAY CONCERN: L. V. Hudson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto H. C. Smith and C. S. Fox

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of - - - - -

- - - - One Thousand Eight Hundred Forty--Two --and 82/100 - DOLLARS (\$ 1,842.82),
with interest thereon from date at the rate of five per centum per annum, said principal and interest to be repaid: six months after date, with interest at five percent, interest to be computed and paid semi-annually until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Birchwood Drive, near the City of Greenville, being shown as Lot No. 27 on a Plat of Kirkwood Heights, recorded in Plat Book EE at Page 110, and described as follows:

BEGINNING at a stake on the northern side of Birchwood Drive, 55 feet east from Edgewood Drive at the corner of Lot 26, and running thence with the line of said Lot, N. 17-56 W. 150 feet to a stake at corner of Lot 41; thence with the lines of Lot 41 and 40, N. 72-04 E. 80 feet to a stake at the corner of Lot 28; thence with the line of said Lot, S. 17-56 E. 150 feet to a stake on Birchwood Drive; thence with the northern side of Birchwood Drive, S. 72-04 W. 80 feet to the beginning corner.

Being the same property conveyed to the Mortgagor by W. K. Stringfellow and G. L. Tidwell, to be recorded herewith.

It is understood and agreed that a lien of this Mortgage is junior to the lien of a Mortgage this day executed to Citizens Lumber Company, in the sum of \$11,500.00.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
