NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the western side of Underwood Avenue, being shown and designated as Lot 49 on plat of Glen Grove Park recorded in Plat Book "F" at Page 233 and having according to said plat the following metes and bounds, to-wit:

"BEGIN ING at an iron pin on the western side of Underwood Avenue at the joint front corner of Lots 48 and 49 and running thence with the western side of Underwood Avenue N. 15-48 E. 50 feet to stake at corner of Lot 50; thence with the line of Lot 50 N. 74-12 W. 150 feet to an iron pin; thence S. 15-48 W. 50 feet to an iron pin corner of Lot 48; thence with the line of Lot 48 S. 74-12 E. 150 feet to the point of beginning."
