Douglas Wilson & Co. in Greenville, South Carolina , or at such other place as the holder of the note may designate in writing, in monthly installments of Forty-Five & 87/100 - - - - - - - - - Dollars (\$ 45.87), commencing on the first day of April , 19 56 , and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March , 19 81 .

Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 148, Paramount Park, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "W", page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Crosby Circle, joint front corner Lots 148 and 149, and running thence S. 13-24 W. 189.9 feet to an iron pin; thence S. 50-30 E. 54.2 feet to an iron pin; thence N. 64-00 E. 79.5 feet to an iron pin, joint rear corner Lots 147 and 148; thence N. 3-24 W. 179.3 feet to an iron pin on the Southerly side of Crosby Circle, joint front corner Lots 147 and 146; thence around the curve of Crosby Circle, the chord of which is N. 85-0 W. 58.7 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
