NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, being a part of the land conveyed to Clarence Lee Ballew and Ethel S. Ballew, by deed of James H. and Annie H. Ballew on April 6, 1948, recorded in the R. M. C. Office for Greenville County in Book 345 at Page 425, and having the following metes and bounds, to-wit:

"BEGINNING in center of bridge on County Road over creek and running thence S. 62 W. 50 feet to bend in road; thence S. 76 W. 200 feet to bend in road; thence S. 72 W. 88 feet to forks of road; thence with Ballew Road, N. 10 E. 275 feet to iron pin in creek; thence with creek as line in a Southeastern direction 325 feet to the beginning corner, containing 1 acre, more or less.
