All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as lot No. 17, on plat of Belmont Heights, recorded in the R. M. C. Office for Greenville County in plat book GG page 54 & 55, and having according to a recent survey made by C. C. Jones, March 1956, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northerly side of Sanford Court, the front joint corner of Lots Nos. 16 & 17; thence with the joint line of said lots N. 25-05 W. 166.6 feet to an iron pin in line of lot No. 15; thence with the line of said lot N. 65-17 E. 126 feet to an iron pin on the southwest side of Conley Street; thence with the southwest side of said Conley Street S. 24-43 E. 160 feet to an iron pin at the corner of the intersection of Conley Street with Sanford Court; thence with the northerly side of Sanford Court S. 62-27 W. 125 feet to the beginning corner.
