"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the northeastern side of Betes Street being shown and designated as Lot 39 on plat of property of H.
