NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, located about one-half mile South from the City of Greer, known and designated as Lots Nos. 22 and 23 on a plat of property known as Woodland Heights, property of I.M. Wood Estate, made by H.S. Brockman, Surveyor, October 28, 1955, recorded in Plat Book GG, at page 151, in the R.M.C. Office for Greenville County, and having the following courses and distances: BEGINNING at an iron pin at the northwestern corner of Buddy Avenue and the J. Waymon Smith Road, and runs thence along the western margin of said road N. 39.55 W. 190 feet to corner of Lot No. 48; thence along the southern margin of this lot S. 45.18 W. 250.2 feet to the joint rear corner of Lots Nos. 47 and 24(iron pin); thence with the eastern margin of Lot No. 24 S. 39.15 E. 190 feet to an iron pin on northern line of Buddy Avenue; thence with said Avenue N. 45.18 E. 252.4 feet to the beginning, and being all of that property conveyed to the mortgagor by E.
