"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as lot # 3, on a plat of Timberlake Section II, recorded in Plat Book BB at Page 184, and described as follows:

"BEGINNING at the joint front corner of lots # 3 and 4 on Timberlake Drive and running thence S. 7-40 W. 95 feet to the joint corners of lots # 1 and 3; thence S. 82-20 E. 180 feet; thence N. 7-40 E. 95 feet to the joint rear corners of lots # 3 and 4; thence N. 82-20 W. 180 feet to the beginning corner.
