To All Whom These Presents May Concern:

I, L. E. Nicholson hereinafter called the Mortgagor, SEND GREETING:

WHEREAS, the said Mortgagor in and by my certain promissory note in writing, of even date with these Presents, am well and truly indebted to BANK OF GREER, GREER, S. C., hereinafter called Mortgagee, in the full and just sum of

Seven Thousand & No/100 - - - - - DOLLARS, to be paid in monthly installments of \$ 75.97, commencing on the 9th day of May, 1956 and on the 9th day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not paid sooner, shall be due and payable on the 9th day of April, 1966.

with interest thereon from date at the rate of 5 1/2 per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that lot of land in Greenville County, State of South Carolina, on the Southeast side of Super Highway No. 29, being shown as lot 212 on a plat of the property of Robert J. Edwards, made by Dalton & Neves, March 1951, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Super Highway No. 29, at the intersection of a 40 foot Road and running thence with said 40 foot road, S. 34 E. 339 feet to an iron pin; thence S. 47-35 W. 63.5 feet to an iron pin at rear of lot 211; thence with line of lot 211, N. 47 W. 325 feet to an iron pin on right-of-way of Super Highway No. 29; thence with the Southeast side of said right-of-way N. 43 E. 139.6 feet to the point of beginning.
