WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Twenty-Two Thousand and No/100 - - - -

(\$.22,000.00...) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the westerly side of Hermitage Road, near the City of Greenville, being known and designated as Lot No. 112, according to plat of Section II, Lake Forest, prepared by Piedmont Engineering Service, dated March 1954, which plat is recorded in the R. M. C. office for Greenville County, South Carolina, in Plat Book "EE", page 71, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the westerly side of Hermitage Road at joint front corner of Lots 111 and 112; thence along the joint line of those lots, N. 86-31 W. 180 feet to an iron pin, joint rear corner Lots 111 and 112; thence S. 3-29 W. 165 feet to an iron pin on the northerly side of a reserved strip; thence along the northerly side of said reserved strip, S. 86-31 E. 155 feet to an iron pin; thence on an angle around a curve, the chord of which is N. 48-29 E. 35.3 feet to a concrete monument on the westerly side of Hermitage Road; thence along Hermitage Road, N. 3-29 E. 140 feet to an iron pin, joint front corner Lots 111 and 112, the point of beginning; being the same conveyed to me by William Maxwell Poe by deed not yet recorded."
