To All Whom These Presents May Concern:

We. Raymond L. Norris and Evelyn W. Norris, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Five Thousand and No/100 -

(\$\frac{5,000.00}{\text{output}}\) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of .

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of the intersection of Smythe Avenue and Stevens Street in the Dunean Mills Village, Greenville County, South Carolina, and being more particularly described as Lot 15 as shown on a plat entitled "Plat Showing Property of J. P. Stevens & Co., Inc., located in Dunean Mill Village, Greenville County, near Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., March 28, 1956, and recorded in the R. M. C. office for Greenville County in Plat Book JJ, at page 167, and having, according to said plat, the following metes and bounds:

"BEGINNING at an iron pin on the Western side of Smythe Avenue at the joint front corner of Lots 14 and 15, and running thence with the common line of said two lots, N. 65-10 W. 199.6 feet to an iron pin on the Eastern side of an alley; thence with the Eastern side of said alley, N. 14-33 E. 69.5 feet to an iron pin; thence still with the Eastern side of said alley, N. 11-55 E. 25.6 feet to an iron pin; thence S. 64-23 E. 112.3 feet to an iron pin; thence N. 25-37 E. 43 feet to an iron pin on the Southern side of Stevens Street; thence with the southern side of Stevens Street, S. 64-23 E. 73 feet to an iron pin; thence S. 41-14 E. 22.7 feet to an iron pin; thence S. 9-24 E. 22.5 feet to an iron pin on the Western side of Smythe Avenue; thence with the Western side of Smythe Avenue, S. 25-51 W. 107 feet to an iron pin, the point of beginning; being the same conveyed to us by J. P. Stevens & Co., Inc. by deed dated April 11, 1956, not yet recorded."

The last payment on this mortgage, if not sooner paid, will become due and payable 15 years after date.
