And said mortgages agrees to keep the building and improvements now standing or hereafter erected upon the mortgaged premises and any and all apparatus, fixtures and apparatus against loss or datage by five and such other hazards as the mortgages may from time to time require, all such insurance to be in forms, in companies and in sums (not less them sufficient to avoid any claim on the part of the insurers for co-insurance) satisfactory to the mortgages, that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the mortgages, and that at least lifteen days; before the expiration of each such policy, a new and sufficient policy to take the place of the one so emploing shall be delivered to the mortgages.
