All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, about one mile west from Washington Baptist Church, lying on the western side of the road that leads from the Greer-O'Neal Road to the Washington Church-O'Neal Road, being bounded on the north by lands of I. E. Duncan, on the east by the said road and lands of Sloan, on the south by lands of Manning Cox and on the west by lands of McAbee, and being a part of the same land that was conveyed to I. E. Duncan by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 363 at page 413, and having the following courses and distances, to wit:
