"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, about three miles southward from Greer, known as the old R.L. Johnson home place, on branch waters of Enorse River and near the Gibbs Shoals Road, bounded by lands now or formerly of Whit "Smith on the North, east, and South by lands of T.R. Childress, and southwest by the Walker Elmore lands, and northwest by Mrs. Cora Hiott lands, having courses and distances according to plat by H.S. Brockman, Surveyor, dated September 28, 1936, as follows:
