State, at Chambers or otherwise, for the designated of a Bessiver, with authority to take charge of the mortgaged premises, designate a reasonable rental, and collect same and apply the net proceeds thereof (after paying cost of collection) upon said debt, interest, take and fife insurence, without liability to account for anything more than the rents and profits actually collected.
