NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Main Street, in the Town of Fountain Inn, Fairview Township, being shown as lot #20, Block 1, Page 346, of the County Block Book, and being more particularly described as follows:

"BEGINNING at the joint corner of property of the mortgagor and lot now or formerly owned by J. P. Kellett, and running thence with Main Street, 33-1/3 feet to pin at corner of lot now or formerly owned by A. G. Edwards Brothers; thence along the line of lot of A. G. Edwards Brothers to point on line of C & W C Railway property; thence along the line of C & W C Railway property 34 feet, more or less, to a pin at rear corner of lot now or formerly owned by J. P. Kellett; thence with the line of the Kellett lot to the point of beginning on Main Street."
