WE, ALVIN H. PHILLIPS AND JEANNE ERNEST PHILLIPS,
WHEREAS, the said mortgagor Alvin H. Phillips and Jeanne Ernest Phillips
in and by a certain promissory note in writing, of even date with these Presents is well and truly indebted to the LIBERTY LIFE INSURANCE COMPANY, a corporation chartered under the laws of the State of South Carolina, in the full and just sum of
(\$ 11,000,00) DOLLARS, to be paid at its Home Office in Greenville, S. C., together with interest thereon from
date hereof until maturity at the rate offour and one-half(43%) per centum
per annum, said principal and interest being payable in monthly instalments as follows:
Beginning on the 1st day of July , 1956, and on the 1st day of
each month of each year thereafter the sum of \$ 69.63
to be applied on the interest and principal of said note, said payments to continue up to and including the _1st
day of, 19_76, and the balance of said principal and interest to be due and navable on the 1st
day of, 19/0; the aforesaid monthly payments of \$ 69.63
each are to be applied first to interest at the rate of four and one-half (4½%) per centum

Office for Greenville County, S. C. in Plat Book "B" at page 144, and having according to said plat and according to a more recent plat prepared by Piedmont Engineering Service dated May 10, 1956, entitled "Property of Alvin H.
