NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Brownwood Drive and being shown as all of Lot 134 and the eastern one-half of Lot 135 on plat of Oak-Crest recorded in Plat Book GG at Pages 130 and 13land when described as a whole has the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Brownwood Drive the joint front corner of Lots 133 and 134 and running thence with the line of Lot 133 S. 29-12 W. 150 feet to an iron pin; thence N. 60-48 E. 115 feet to an iron pin in center of rear line of Lot 135; thence through center of Lot 135 N. 29-12 E. 150 feet to an iron pin on Brownwood Drive, said pin being in the center of the front line of Lot 135; thence with the southern side of Brownwood Drive S. 60-48 E. 115 feet to the point of beginning."
