All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situ-

ate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 173 of Oak Crest Subdivision as shown on a plat of said subdivision prepared by C. C. Jones & Associates, dated January, 1955, revised August, 1955, recorded in the R. M. C. Office for Greenville County in Plat Book GG at pages 130 and 131, and having according to said plat the following metes and bounds:
