SEND GREETING:

Whereas, I, the said Betty Pridmore Dyke  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to Citizens Bank (Fountain Inn, S. C.)  
in the full and just sum of Three Hundred Eighty-Five & no/100 - - Dollars  
, to be paid one year after date

, with interest thereon from date  
at the rate of 6 per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises

and distances to-wit: Beginning at an iron pin in the center of the  
Babbtown Road, the corner being the North corner adjacent to the Ethel  
Pridmore tract, running thence S. 50-45 W. 384.2 feet to an iron pin;  
thence S. 21-48 E. 120 feet to an iron pin; thence N. 50-45 E. 384.2  
feet to an iron pin in the center of the Babbtown Road; thence along  
the center of the Babbtown Road N. 21-48 W. 120 feet to the point of  
beginning, and containing one acre, more or less.
