NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, situate on the southern side of North Franklin Road and being known as the northwestern portion of Tract No. 4 on a plat of the property of Ollie C. Dill and others, recorded in Plat Book B at page 135 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of the North Franklin Road at the joint front corner of Tracts 3 and 4 and running thence with the southern side of North Franklin Road, S. 81 E. 130 feet to an iron pin at corner of lot heretofore conveyed to H. P. Dill, Jr.; thence with the line of said tract, S. 6 E. 257.8 feet to an iron pin; thence S. 88 N. 130 feet to an iron pin in Tract #3; thence with the line of Tract #3, N. 6-10 E. 286.5 feet to the point of beginning.
