NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Graenville, in the City of Greer and in Chick Springs Township, located at the intersection of Kay and Brown Streets, being all of Lot No. 50 on a plat of the N.M.

Cannon property, which plat is on record in the R.M.C. Office for Greenville County in Plat Book F, at page 199, and having the following courses and distances: BEGINNING at a point on the East side of Kay Street, at intersection with Brown Street, and runs thence with the eastern edge of Kay Street S. 13.00 E. 160 feet to an iron pin; thence N. 76.45 E. 61 feet along northern edge of Springdale Street to an iron pin; thence N. 13 W. 160 feet to an iron pin on the south side of Brown Street; thence therewith S. 76.45 W. 61 feet to the beginning corner, and being all of that property as conveyed to the mortgagor by C.E.
