All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Green, in Chick Springs Township, lying on the South side of Arlington Avenue and on the West side of Miller Street, bounded on the South by Mrs. T.W. Glenn and on the West by lands of T.N. Clement, having the following courses and distances: BEGINNING at an iron pin on the West side of Miller Street, Glenn's corner, and runs thence with the west side of Miller Street 102 fest to Arlington Avenue; thence with the south side of Arlington Avenue in a westermly direction 199 feet to an iron pin, Clement's corner; thence with Clement's line in a southerly direction 66 feet to an iron pin, back corner of Glenn's lot; thence with the line of the Glenn lot in an easterly direction 187 feet to the beginning corner, and being all of that property conveyed to the mortgagor by W.F. and Margueritte W.
