

VILLE, in the full and just sum of Four Thousand, Six Hundred and No/100 - - - - - - - - (\$\frac{4,600.00}{\text{00}}\) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, south of the Lee Road and west of the Edwards Road, containing 11.96 acres, and having, according to a plat of the property of Rachel S. Burns prepared by C. O. Riddle, L. S., May, 1956, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of the Lee Road at the eastern corner of the intersection of said road with a 20-foot driveway, and running thence along the eastern side of said 20-foot driveway, S. 8-41 E. 219.3 feet to an iron pin; thence N. 62-36 E. 300 feet to an iron pin (which is the rear corner of Lot No. 1 as shown on plat recorded in the R. M. C. office for Greenville County in Plat Book T, page 240); thence N. 80-15 E. 293.8 feet to an iron pin (which is a rear corner of Lot No. 4 as shown on said plat recorded in Plat Book T, at page 240); thence N. 85-35 E. 249.4 feet to an iron pin; thence N. 86-08 E. 199.8 feet to an iron pin; thence N. 4-53 W. 220 feet to an iron pin on the southern side of the Lee Road; thence along the southern side of the Lee Road, N. 85-50 E. 448.5 feet to an iron pin; thence along the southern side of the Lee Road as it intersects with the Edwards Road, following the curvature of said intersection, the chord of which is S. 27-23 E. 19 feet to an iron pin on the northwestern side of the Edwards Road; thence along the northwestern side of the Edwards Road, S. 33-20 W. 137.1 feet, S. 37-48 W. 190 feet, and S. 45-04 W. 259.3 feet to an iron pin at the corner of a lot now owned by Mrs. Ila Stephens; thence along the line of the Stephens lot, N. 69-43 W. 241 feet to an iron pin; thence S. 17-48 W. 206.4 feet to an iron pin; thence S. 69-43 E. 180 feet to an iron pin on the northwestern side of the Edwards Road; thence along the northwestern side of the Edwards Road, S. 32-10 W. 236 feet to an iron pin; thence N. 57-07 W. 223.9 feet to an iron pin; thence S. 83-44 W. 599.9 feet to an iron pin; thence N. 9-33 W. 527.5 feet to an iron pin on the southern side of the Lee Road; thence along the southern side of the Lee Road, N. 62-51 E. 20.2 feet to the beginning corner; being a portion of the property conveyed to me by Ealy D. Pirkle by his deed dated November 4, 1938, recorded in the R. M. C. office for Greenville County in Deed Vol. 207, page 138."
