In monthly installments of \$140.00 each on the 16th day of each and every month hereafter, to be applied first to interest and then to principal until paid in full; with interest thereon from date at the rate of six per cent, per annum, to be computed semi-annually and paid monthly, until paid in full,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Berry Hill Road near the City of Greenville, and being shown as Lot #104 on a plat of Section 2 of Lake Forest, recorded in Plat Book EE at page 71 and described as follows:

BEGINNING at a stake on the Southwestern side of Berry Hill Road 140.3 feet Southeast from Edwards road at the corner of Lot 105, and running thence with the lime of said lot, S. 51-24 W. 204.2 feet passing an iron pin to a point in the center of Brushy Creek; thence with Brushy Creek as a line, the traverse of which is S. 35-18 E. 114.2 feet to a point at corner of lot #103; thence with the line of said lot, N. 53-09 E. 216.9 feet, passing a pin near the bank of the creek to a stake on the Southern side of Berry Hill Road; thence with the Southwestern side of said road, N. 37-40 W. 120 feet to the beginning corner.
