A. Cureton, Jr., Roy W. Cureton and South Carolina National Bank of Greenville as Trustee under the will of J. A. Cureton, deceased, all that tract or lot of land in

Taxaskipx Greenville County, State of South Carolina, on the Southwest side of Bishop Street, near the City of Greenville, being known and designated as Lots 59, 61 and 63 according to plat of property of H. B. Bates, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book F, page 32, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a stake on the Southwest side of Bishop Street, 250 feet Southeast from Center Street, at corner of Lot 57, and running thence with the line of said lot S. 48-30 W. 142.5 feet to a stake at corner of lot 58; thence with the lines of Lots 58, 60 and 62, S. 55-40 E. 150 feet to a stake in line of Lot 66; thence with lines of Lots 66 and 67, N. 48-30 E. 142.5 feet to a stake on Bishop Street; thence with the Southwest side of Bishop Street N. 55-40 W. 150 feet to the beginning corner, less, however, that portion of the above described property conveyed by Herbert Syracuse to Josie F.
