NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township on the North side of the Rifle Range Road in Little Texas, bounded by G. C. Kelley, J. H. Ferguson, H. Y. Hawkins, et al., and containing 10.54 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at a branch; thence N. 70-30 W. 445 feet to an iron pin; thence S. 28-15 W. 380 feet to an iron pin; thence S. 57 W. 323 feet to an iron pin in road; thence along said road S. 27-33 E. 267 feet to an iron pin; thence S. 70-03 E. 549.3 feet to an iron pin in branch; thence along the meanders of said branch, N. 16-50 E. 818 feet to the beginning.
