C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the East side of the Buncombe Road, about 1 mile West of the Town of Greer, S. C., and having the following metes and bounds to wit:-

BEGINNING at an iron pin in the Buncombe Road, the Northwestern corner of said tract and runs thence N. 60 E. 397 feet to an iron pin; thence along the line of land now and formerly owned by C. L.
