That certain lot of land, with the improvements thereon, in School District #285, Chick Springs Township, said County and State, on the northern side of Maryland Avenue as shown on subdivision plat #2 of the Victor-Monaghan Co., Division of J. P. Stevens & Co., (known as Green Mill village), recorded in Plat Book P at page 119, and having the following courses and distances, to-wit:

Beginning at a point on the northern side of Maryland Avenue, Joint corner of Lots Nos. 56 and 57¢ thence with the common line of said Lots, N 35-21 E one hundred seventy (170) feet to a point on the southern side of a ten-foot alley; thence with said alley, N 54-39 W one hundred (100) feet to a point, joint rear corner of Lots Nos. 57 and 59; thence with the common line of said lots, S 35-21 W one hundred seventy (170) feet to a point on the northern side of Maryland Avenue; thence therewith, S 54-30 E one hundred (100) feet to the beginning point, and designated as Lot No. 57 on said plat.
