WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

being known and designated as Lots Nos. 90, 91 and 92 as shown on Map #2 of Nicholtown Heights, prepared by W. J. Riddle, in April, 1941, recorded in the R.M.C. Office for Greenville County in Plat Book M, at page 5, and being more particularly described as follows:

BEGINNING at an iron pin on the North side of River Street, which pin is 242 feet East of River Street and Hilton Street and joint front corners of Lots Nos. 89 and 90, and running thence with the line of Lot No. 89, N. 8-45 W. 116.4 feet to an iron pin; thence N. 81-15 E. 120 feet to an iron pin at rear corner of Lot No. 93; thence with the line of Lot No. 93, S. 8-45 E. 116.4 feet to an iron pin on North side of River Street; thence with the line of River Street, S. 81-15 W. 120 feet to the point of beginning.
